- 事業主が給与から被保険者負担分を控除するときの端数処理は、被保険者負担分に端数が生じた場合、50銭以下のときはその端数は切り捨てし、50銭を超えるときは切り上げて1円となります。
- ※ 事業主と被保険者との間で特約がある場合は、その特約に基づき端数処理することができます。
- 保険料月額表の全額欄から個人負担額欄の金額を差し引いた額が事業主負担額となります。なお、基本保険料率(63.00/1000)の中には、調整保険料率(1.07/1000)が含まれています。
- 賞与を支給した時は、標準賞与額(賞与支給額の1,000円未満を切り捨てた額)に保険料月額表と同率を乗じた額が保険料になります。年度(毎年4月1日から翌年3月31日)の累計額573万円が上限です。
- 事業主の皆様におかれましては、被保険者負担分の保険料を徴収する際に、被保険者の方々に対して特定保険料率の理解を深めていただくため、給与明細書等に特定保険料額及び基本保険料額を示すことなど、特定保険料の情報提供に努めていただきますようご理解とご協力をお願いします。
